In the following statement, we provide details of our practices designed to protect human rights in our global supply chain. Organization

Suppliers are audited by the relevant issuing authorities to ensure compliance with such quality standards and other regulatory requirements. Indirect suppliers are also subject to similar qualifying approval processes.

AMETEK promotes diversity, as well as fosters cultures and work environments based on respect and empowerment.
